

AN ACT to Amend the National Insurance Act; and for  
connected matters.

[ December 24, 2012 ]

BE IT ENACTED by The Queen's Most Excellent Majesty, by and  
with the advice and consent of the Senate and House of  
Representatives of Jamaica, and by the authority of the same, as  
follows:—

1. This Act may be cited as the National Insurance (Amendment) Short title.  
Act, 2012.

2.—(1) Subject to section 3, the provisions of the National Amendment  
and

Schedule.  
Insurance Act (hereinafter referred to as “the Act”) and the other  
enactments specified in the first column of the Schedule are amended  
in the manner specified respectively, in relation to them in the second  
column of the Schedule.

(2) Each amendment so specified shall be read and construed as one with the enactment specified in relation to that amendment and all other amendments to the enactment.

**3.** The amendments specified in the second column of the Schedule shall come into operation, in relation to—

- (a) section 5 of and the Second Schedule to the Act, on the 7th day of January, 2013;
- (b) sections 10A and 21 of and the Third Schedule to the Act, on the 10th day of January, 2013;
- (c) regulation 4 of the National Insurance (General Benefits) Regulations, 1966, on the 10th day of January, 2013; and
- (d) regulation 3 of the National Insurance (Sugar Workers Transitional) Regulations, 1966, on the 10th day of January, 2013.

Section 5	In relation to subsection (2)(a), delete the symbol and numerals "\$1,000,000.00" and substitute therefor the symbol and numerals "\$1,500,000.00".
Section 10A	Delete section 10A and substitute therefor the following—  "Special pensioner. 10A. Subject to the provisions of this Act, a person born before the 1st day of January, 1908, (hereinafter called a "special pensioner") shall be entitled to a pension under this Act at a rate of \$1,400.00 per week."
Section 21	Delete the words "eight hundred" wherever they appear and substitute therefor, in each case, the words "nine hundred".
Second Schedule	1. In relation to paragraph 1 (a), in the second column under the—  (a) sub-heading "Payable by Insured Person"; and  (b) sub-heading "Payable by Employer", delete the symbol and numerals "\$25.00" and substitute therefor, in each case, the symbol and numerals "\$50.00".  2. In relation to paragraph 1 (b), in the second column under the sub-heading "Payable by Insured Person" and the sub-heading "Payable by Employer", respectively—  (a) delete the symbol and numerals "\$19,230.76" and substitute therefor, in each case, the symbol and numerals "\$28,846.00";

(a) in the second column, under the sub-heading "Basic", delete the symbol and numerals "\$4,200.00" and substitute therefor the symbol and numerals "\$4,900.00";

(b) in the third column, under the sub-heading "Basic", delete the symbol and numerals "\$48,000.00" and substitute therefor the symbol and numerals "\$55,000.00".

4. In relation to paragraph 7 (funeral grant) in the third column, under the sub-heading "Basic", delete the symbol and numerals "\$70,000.00" and substitute therefor the symbol and numerals "\$80,000.00".

Regulation 4

Delete paragraphs (2) and (3), and substitute therefor the following—

" (2) Where the yearly average is less than thirty-nine but not less than twenty-six, benefit shall be payable at the rate of \$2,100.00 per week.

(3) Where the yearly average is less than twenty-six, benefit shall be payable at the rate of \$1,400.00 per week."
