THE MUTUAL ASSISTANCE (CRIMINAL MATTERS) ACT

The Mutual Assistance (Criminal Matters) (Designated Commonwealth States) (Amendment) Order, 2012

In exercise of the power conferred upon the Minister by section 31(1) of the Mutual Assistance (Criminal Matters) Act, the following Order is hereby made:-

1. This Order may be cited as the Mutual Assistance (Criminal Matters) (Designated Commonwealth States) (Amendment) Order, 2012, and shall be read and construed as one with the Mutual Assistance (Criminal Matters) (Designated Commonwealth States) Order, 1995, hereinafter referred to as the principal Order.

2. The Schedule to the principal Order is amended by deleting the word "Britain" and inserting immediately under the word "Uganda" the words -

"United Kingdom and the following British Overseas Territories:

British Virgin Islands

Cayman Islands

Montserrat

Turks and Caicos Islands".

THE MUTUAL ASSISTANCE (CRIMINAL MATTERS) ACT

The Mutual Assistance (Criminal Matters) (Designated Commonwealth States) (Amendment) Order, 2012 Resolution
